The response to the hospital is encouraging. As numbers of patients are increasing day by day and patients need better medical facilities under one roof, there is a need of advance machineries & technology. It has become very difficult to carry out to the management to deal successfully with the demands. We requested to the committees of Vasai Pragati Credit Society Ltd & they have given us Gods hand to overcome all this. We purchased an advance & modern machineries of Rs. 30, 00,000/- from their donation.

Future Plans:

- Requirement of Departments: The response to the hospital is encouraging and there is a need of expansion to accommodate the department of Sonography, Cardiology, Pediatric, & Gynecology.
- Palliative Care: Though palliative patient's care is taken at present, we have limited beds and the number of such patients is increasing and there is a need for eldercare too as the social structure of India's families' changes the "graying of the globe" affects even rural. Many elder persons find themselves neglected or displaced in their last years. The Trust is finding a solution that respects the elders' dignity and autonomy and best medical treatment is given to them and they are taken care of medically. Plans are already underway to build an Eldercare Facility Department. The trust has already purchased additional land and an extension of 4000 sq. ft. is to be built for the above mentioned departments.
